#### **MEETING MINUTEES**

### October 22, 2024

The regular monthly meeting of LULAC Council 8003 was called to order by President Fred Baca at 5:41pm at the Polo Sierra LULAC Hall. The opening prayer was led by Frances Vasquez in the absence of the Chaplain. We recited the Pledge of Allegiance.

INTRODUCTION OF GUEST(S): Norm Wheeler, candidate for Sixth Judicial District Attorney, was present. He was accompanied by Fred Jimenez, Delfina Jimenez, and Amy.Lockett. Mr. Wheeler introduced himself and spoke to us regarding his candidacy. Mr. Wheeler and guests then departed the meeting.

MINUTES FROM THE PREVIOUS MEETING OF AUGUST 13, 2024: Copies of the minutes of the previous meeting were available for review. Fred Marquez made a motion to approve the minutes as presented. Renee seconded the motion and vote was unanimous in favor of the motion.

There was discussion. Bea McKinney made a motion that LULAC award a scholarship to Javier Marrufo in the amount of \$1000. It was agreed to use \$700 from the savings account/scholarship fund and Bea will donate the remaining \$300. Renee seconded the motion and vote was unanimous in favor of the motion. Weeds have been cut courtesy of the Juvenile Justice Program led by Mr. Stailey and Mr. Barris. Fred Baca continues to seek a solution to the bald concrete floor. Fred Baca reported that the swamp cooler has been shut off and the furnace is working.

National LULAC – Fred Baca reported that a Political Pac has been formed and federal candidate will be endorsed.

New Mexico State LULAC – Javier Marrufo was a guest speaker in Alamogordo on Oct 12.
